

- 4. An approved lifejacket light meeting the requirements of the LSA Code Regulation II/2.2.3 together with a whistle meeting the requirements of LSA Code regulations II/2.2.1.14 are to be fitted. The light is to be tested and meet the requirements of IMO Resolution MSC.81(70), Part I, 10.3 and 10.4, and its attachment to the Lifejacket confirmed.

- 6. Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D), a Product-Quality assurance system (Module E) or a Product Verification Process. The wheelmark cannot be affixed to the product until a conformity assessment module is in place.
- 7. Production tests are to be conducted in accordance with the applicable requirements of IMO Resolution MSC.81(70), Part 2 and be recorded by the manufacturer in accordance with either the approved Production Quality Assurance system (Module D), a Product Quality Assurance (Module E) or witnessed by the Notified Body (LR) as required by the Product Verification (Module F) of the Marine Equipment Directive. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration.
- 8. Each item, batch or lot of the equipment is to be issued with a "Declaration of Conformity" and have the "Mark of Conformity" affixed after a conformity assessment module is in place.
- 9. Should a change of Place of Production from that stated below be required i.e. where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained.
